2018 marks the 25th Anniversary of DSC's Tree of Hope Campaign – a milestone year where we are celebrating 25 years of success in our history and using it as a catalyst to keep making genuine impact in the lives of the people who choose DSC services in the years to come. With a goal of \$40,000, the Tree of Hope began in 1994 and the same concept that started this tradition continues today - a family has chosen to share their story with

our community demonstrating how DSC's involvement in their lives has made a difference for them. Over the years, we have introduced 28 children, and their families, who have received services from DSC, to our community. Today, they range in age from young adults to preschool, but in all cases, their lives improved through the early intervention services they received.

At the Tree of Hope Kick-Off event, we not only introduced this year's Spokesfamily, the Dilley Family and announced the \$175,000 goal for this year's campaign, but we also reintroduced five young adults, Alex Webber, Ashley, Emily, and Kailey Eisenmenger, and Kelly Jane Griffin who were the focus of the Tree of Hope campaigns in 1996, 1999, and 2001 respectively. We hope you take a moment to visit our website to watch the videos of their lives. We invite you to view their stories from the point in which we met them to where they are today. At Kick-Off, we also held our traditional Recognition Event where we celebrated three awards:
